




Key Takeaway



After two years of tightening, 2025 marked a turning point as the Federal Reserve began cutting rates.


Markets showed little reaction, reflecting uncertainty as policymakers navigate between supporting growth and managing cooling labor conditions.



Policy headlines may rattle sentiment, but fundamentals and broader economic health drive market performance. Staying invested through turbulence remains one of the most powerful forms of discipline.


Nasdaq Composite Level % Change; S&P 500 Level % Change & Dow Jones Industrial Average Level % Change




